 IZSLT will provide support to Bosnia and Herzegovina and serve as Confirmatory Laboratory for GMO analysis when needed.

 Food safety Agency is obliged to collect samples for confirmatory testing's and send them to IZSLT by agreed route.

 IZSLT will perform requested testing's and provide test results to Food safety Agency in shortest possible time.

Food Safety Agency in collaboration with authorities of BiH, entities and Brcko
District in accordance to law ordinances will pay to IZSLT cost of analysis in
shortest possible time.
